

SZIGET TOGETHER ONLINE COMPETITION

RULES OF PARTICIPATION

These present Rules of Participation (hereinafter: „**Rules**”) set forth the terms of participation in the „Sziget Together Online Competition” (hereinafter „**Competition**”).

1. Organiser and implementer of the Competition

The Competition is organised by **Sziget Cultural Management Ltd.**, (1033 Budapest, Hajógyári sziget, hrsz. 23796/58., Hungary; tax number: 26189905-2-44; registration number: 01 10-049598, hereinafter **the Organiser**).

All natural persons who participate in the Competition (hereinafter „**Competitor**”) accept these Rules and the Competition’s Privacy Notice as binding without any further legal act.

The Organiser is entitled to change these Rules at any time unilaterally without any notification.

2. Terms of participation

Any individual who has a valid passport or identity card and are over 18 years old may take part in the Competition.

The proprietors of the Organiser and of the contributors directly involved in conducting the Competition, and their executive officers, employees, agents, and their close relatives [Ptk. 8:1 § (1)] may not participate in the Competition as Competitors.

3. Term of the Competition

The Competition shall be held between 12.00, August 5, 2020, and 24.00, August 11, 2020 (CET). The Organiser has the right to change the term of the Competition.

The competition days are the followings:

1. competition day: 12.00, August 5, 2020 – 24.00, August 5, 2020
2. competition day: 12.00, August 6, 2020 – 24.00, August 6, 2020
3. competition day: 12.00, August 7, 2020 – 24.00, August 7, 2020
4. competition day: 12.00, August 8, 2020 – 24.00, August 8, 2020
5. competition day: 12.00, August 9, 2020 – 24.00, August 9, 2020
6. competition day: 12.00, August 10, 2020 – 24.00, August 10, 2020
7. competition day: 12.00, August 11, 2020 – 24.00, August 11, 2020

4. Description of the Competition

The Organiser draws the Competitors’ attention to the Competition on its Instagram and Facebook pages by posting about the Competition. All natural persons participate in the Competition who completes the task given in the Facebook or Instagram post as determined there.

If the task is uploading a photo the Competitor is entitled to upload only one photo. If any other person than the Competitor is displayed on the photo, the Competitor shall obtain the permission and consent of the that other person regarding the use, evaluation and data

processing concerning the given photo in connection with the Competition. In the event of the publication of the photo it shall be deemed that the Competitor has obtained the aforementioned permission and consent. The Organiser's liability is excluded in this regard.

The Organiser hereby notes that any photo that contains a violent, obscene, pornographic or sexual, religious, political, hatred-inciting or otherwise offensive element, is offensive to others on the basis of ethnicity, religion, nationality, gender, political or other identity or in any way, violates the personal or intellectual property rights of others, or is of poor quality (blurred), or is inappropriate in the Organiser's subjective judgement, will be held invalid. Any application with a photo of this nature will be disqualified by the Organiser.

The Organiser excludes from the Competition whoever endangers the fair conduct of the Competition in any way.

Completing a task is considered to be an application to participate and is also considered to be a consent to evaluate the task by a 3-member jury of the Organiser's employees, and the acceptance of these Rules and the Privacy Notice.

The completed tasks are evaluated every day by a jury that chooses the most creative photo/comment etc.. The Competitor who has been chosen by the jury at the given day (hereinafter „**Winner**” or „**Winners**”) is entitled to receive the prize (hereinafter „**Prize**”) set forth in these Rules. Each day has as many Winners as determined in the respective post.

The jury selects a new Winner, if the Winner loses his or her right to receive the Prize, or does not fulfil his or her obligation in the given term to get the Prize, or he or she refuses to get the Prize.

The Winners will be notified by the Organiser within 24 hours after the closing time of the given task via Facebook or Instagram message.

5. The Prize

The Winner is entitled to get the Prize determined in the given post.

The Prize may not be exchanged for money. Neither the Winners, nor others are entitled to demand from the Organiser to exchange the Prize to money or to any other gift.

The Organiser does not provide any other gifts or prizes in the Competition other than determined in the posts.

The Organiser undertakes to pay the personal income tax directly applicable to the Prize and the amount of any additional tax or other contributions directly related to the Prize. However, other costs related to the Competition are borne by the Winner.

6. Receiving the Prize

The Winner shall be required to provide his or her personal data necessary for handing over the Prize to the Organiser in 3 days after being notified via Facebook or Instagram message. If the Winner does not fulfil this obligation within the aforementioned time, he or she loses his or her right to receive the Prize.

7. Responsibility matters

If there is abuse or any suspicion of abuse during the time of the Competition, the Organiser reserves the right to suspend or to terminate the Competition or to exclude the offender from the Competition. In such a case, the Organiser excludes its all liability.

The Winners bear all consequences of giving incorrect personal data or if their mailboxes can not receive letters. The Organiser does not check the correctness of the aforementioned personal data. In this regard the Winners exclusively bear all responsibility and all legal and financial consequences.

The Organiser excludes responsibility for any demand for compensation or indemnification or for any cost, damage, loss incurred by the Competitor as a result of participating in the Competition. By participating in the Competition the Competitor expressly waives his or her right to have any demand relating to conducting the Competition, the Prize, the Winners, the Organiser or any other third parties.

If the task is uploading a photo the Competitor is entitled to upload only one photo. If any other person than the Competitor is displayed on the photo, the Competitor shall obtain the permission and consent of the that other person regarding the use, evaluation and data processing concerning the given photo in connection with the Competition. In the event of the publication of the photo it shall be deemed that the Competitor has obtained the aforementioned permission and consent. The Organiser's liability is excluded in this regard.

The Organiser excludes its liability for any copyright infringement.

The Organiser shall not bear any responsibility if the webpage that contains these Rules periodically can not be found due to technical reasons during the term of the Competition. The Organiser shall not be liable for problems with the webpage and for their consequences beyond its control (for example technical problems or break-down in the internet system).

Facebook and Instagram do not support this Competition in any form, they have not ordered it and they do not operate it.
