Purpose of processing	To exercise the right of access pursuant to Article 15 of the GDPR. To answer the questions of the data subjects related to processing of their personal data and to the exercise of their rights under the GDPR.
Duration of processing	The Controller deletes the personal data 5 years after the receipt of the request (question/comment/complaint).
Legal basis for processing	Legitimate interest of the Controller pursuant to Article 6 (1) f) of the GDPR.

	<p>The legitimate interest of the Controller is to comply with Preamble (59) of the GDPR, thus to answer the data subjects' requests within 1 month. The data processing is necessary because the Controller is obliged to prove that it has responded and the Controller is complied with the legal requirements.</p>
<p>Transfer</p>	
<p>Personal data are processed by the employees of the Controller in order to achieve the abovementioned purpose.</p>	
<p>No personal data will be transferred to third countries or to international organisations.</p>	
<p>Rights, legal remedies, complaints</p>	
<p>Pursuant to the GDPR, during the data processing, you may request access to the personal data and may request information about data processing (which will be provided by the Controller within no more than 1 month), may request rectification of personal data or the restriction of data processing, and you have the right to object.</p>
