## SZIGET FESTIVAL CAMP POLICY

## DEAR CAMPER,

If you use the camping areas of Sziget Festival organised by Sziget Cultural Management Ltd. (Sziget), you have to comply with the mandatory rules of conduct of the camping areas.

- 1. Visitors are admitted to the camping area at the times and according to the conditions specified on their ticket.
- 2. One Visitor is only entitled to occupy an area of maximum 6 square meters.
- 3. If Sziget staff ask the Visitors to demolish their shading tents or beer tents, they are obliged to obey immediately.
- 4. Sziget asks Visitors to set up their tents exclusively at the designated areas, making sure, that they leave the escape routes, fire lanes and restricted areas free. If a Visitor fails to comply with this safety requirement, Sziget staff or the employees of the National Directorate General for Disaster Management is entitled to ask the Visitor to move his or her tent to a designated area. It is forbidden to camp at the restricted areas.
- 5. As a general rule power reception is prohibited, except at the Caravan camping and at certain parts of the Staff Camping. At the Caravan camping and at the Staff Camping power reception is permitted only with the permission of the given camp leader. Failure to comply with the rules set out in this section for the first time will result in a warning, while at the second offense the Visitor will be expelled from the camping area.
- 6. When power reception is permitted, only a device with a maximum output of 1000 W may be connected to a single reception point. Exclusively one extension cord up to 40 meters may be connected to a single reception point. One reception point may be divided into 6 with distributors. The connection point of the extension cord or the distributor must not placed directly on the ground, furthermore, it is essential to provide protection against electric shock. If the connection is inappropriate, the Visitor is obliged to terminate it at the request of the Sziget staff.
- 7. For safety reasons it is prohibited to use air conditioner, electric stove, electric kettle, gas stove or fridge at the camping areas. Exceptions to this rule may be made for rented equipment belonging to the accommodation or equipment installed in a caravan.
- 8. Entry in a vehicle to the camping areas is forbidden with the exception of a vehicle carrying out cleaning or maintenance, a vehicle that has the vehicle entry permit of the camp leader and the staff's motorbikes. Caravan may only park in the camping areas with the permission of the camp leader, although, the vehicle towing it must leave the camping area immediately after parking the caravan.

- 9. Sziget draws attention to the fact that it is strictly forbidden to damage trees (for example breaking branches, nailing anything to the trees, cutting out trees).
- 10. Please do not disturb the peace of others by listening to loud music between 2am and 8am.
- 11. Sziget may not be held responsible in connection with the Visitor's objects that can be found at the camping areas, therefore Sziget is not responsible for any damage or loss of the Visitor's property caused by another Visitor, or anyone else.
- 12. Any Visitor who causes damage to the facilities, equipment or infrastructure located at the camping areas shall be liable for such damage.
- 13. The Visitor is obliged to notify the Camp reception of any failure of the equipment, about tort, and also about violation of this Camp Policy.
- 14. For all questions not regulated herein Sziget Festival Visitor Policy and Sziget's General Terms and Conditions shall apply.
