<p>Purpose of data processing</p>	<p>On basis of Paragraph 1 of Section 9/H of Act 156 of 2016, the above personal data are processed for the protection of rights, safety and property of the data subject and others, furthermore, for the control the compliance with the provisions on the stay of citizens of third countries and persons entitled to the freedom of movement and residence</p>	<p>The above personal data are processed on basis of Paragraph 3 of Section 12 of Municipal Decree of 49/2008. (IX. 30.) of Budapest Capital 3rd District Municipality, for collecting the touristic tax.</p>
<p>Duration of processing</p>	<p>Until the last day of the year following the date of provision of the data.</p>	<p>Until the end of the limitation period for the determination of the tax.</p>
<p>Legal basis for processing</p>	<p>On basis of Point c) of Paragraph 1 of Section 6 of the GDPR, the legal basis for processing is the fulfillment of legal obligation of the Controller.</p>	
<p>Data processing, data transfer</p>	<p>Employees of the Controller are processing the personal data designated in Paragraph 1 of Section 9/H of Act 156 of 2016 on the State Tasks of Development of Touristic Areas to achieve the abovementioned purpose.</p> <p>On basis of Governmental Decree 235/2019. (X. 15.), after recording the personal data on the host, the Hungarian Touristic Agency shall proceed, as defined therein, as data processor for the personal data determined in Paragraph 1 of Section 9/H of Act 156 of 2016 on the State Tasks of Development of Touristic Areas. On basis of Section 9/A of Act 156 of 2016, the Controller shall transfer statistical and event-driven data, which are not containing personal data, to National Touristic Data Provider Centre operating under the supervision of Hungarian Touristic Agency. No personal data will be transferred to third countries or to international organisations. If you feel that the Controller has violated any of the legal provisions applicable to data processing, please contact the Controller first, using any of the above contact information, or at the following email address: dpo@sziget.hu.
